**AGREED ORDER ON TRUSTEE'S MOTION TO SELL PROPERTY  
FREE AND CLEAR OF LIENS, CLAIMS AND ENCUMBRANCES**

UPON considering the Trustee's Motion to Sell Property Free and Clear of Liens ("Motion") pursuant to Section 363(f) filed in the above captioned case, the Court sets forth the following:

1. Trustee filed the Motion pursuant to Section 363(f) on March 13, 2018 [Doc No. 41], and requested to sell the Debtor's interests in certain property subject to the prior perfected security interests of the referenced Secured Creditors in the amount of \$5,223,895.79 but free and clear of any other liens or interests to Arundel Ventures, LLC or its assignees, 3400 Carlisle #550, Dallas, Texas 75204, for \$200,000.00.

2. Trustee represents that the Motion was filed and served on all parties in interest pursuant to Local Rule 9007. The last date for filing objections was April 3, 2018 which has

passed with one objection thereto being served and filed. A Limited Objection to Motion to Sell was filed April 3, 2018 [Doc No. 47] by Twitter, Inc.

Having been informed that counsel for the Trustee and counsel for Twitter have reached an agreement regarding the requested relief, and finding cause to approve such agreement; it is hereby:

ORDERED, ADJUDGED AND DECREED by this Court that the Trustee's Motion is hereby granted and the Trustee is allowed to sell the Patents (as defined in the Trustee's Motion) subject to the referenced Secured Creditors (as defined in the Trustee's Motion) secured claims as set forth in the Motion free and clear of any other liens or interests for \$200,000.00.

IT IS FURTHER ORDERED by this Court that neither this Sale Order nor the sale approved herein shall prejudice, bar or otherwise affect (i) the continuation of proceeding numbers IPR2017-00829, IPR2017-00830, IPR2017-01131 and IPR2017-01133 (the "**Pending IPR Proceedings**") in front of the Patent and Trial Appeal Board (the "**PTAB**") of the United States Patent and Trademark Office; (ii) Twitter's participation in the Pending IPR Proceedings (iii) Twitter's right to fully defend against any claims or causes of action asserted in the Patent Litigation.
