PETITIONER'S REQUEST FOR ORAL ARGUMENT

Petitioner Samsung Electronics Co., Ltd. and Samsung Electronics America Inc. (collectively “Petitioner”) respectfully requests oral argument in connection with IPR2017-01190 for U.S. Patent No. 6,717,518 (“the ’518 Patent”). Pursuant to 37 C.F.R. § 42.70, Petitioner specifies the following issues to be argued:

- Grounds for which *inter partes* review was instituted for the ’518 Patent and any issue raised in the Board’s Institution Decision, including the Board’s Supplemental Institution Decision entered May 3, 2018 (Paper No. 24), instituting review on all claims and grounds presented in the Petition;
- Any issue addressed in Petitioner’s papers, including but not limited to the Petition and Petitioner’s Reply Brief;
- Rebuttal to Patent Owner’s presentation on all issues, including the issues identified above and any issues raised in Patent Owner’s Response and exhibits cited therein.
- Any issues raised by the Board or Patent Owner at oral argument;
- Any other issues raised in papers filed in this proceeding, including issues raised in papers yet to be filed; and
- Any other issues that the Board deems necessary for issuing a final written decision.

Pursuant to the Scheduling Order (Paper 12 at 4, 7) the oral hearing for this case IPR2017-01190 is currently scheduled for June 29, 2018. Petitioner requests 45 minutes or half of the time that the Board determines is appropriate for oral argument and expressly reserves the right to use a portion of its time for rebuttal. Petitioner additionally requests that the Board provide audio-visual equipment to display demonstrative exhibits, including a monitor or projector to be connected to a laptop, a screen, and an ELMO for displaying documents of record.
