Pursuant to 35 U.S.C. §§ 141 and 142 and 37 C.F.R. §§ 90.2 and 90.3, Patent Owner Uniloc 2017 LLC. (“Patent Owner”) hereby provides notice that it cross-appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered October 25, 2018 (Paper No. 24) and from all underlying findings, orders, decisions, rulings, and opinions, including, without limitation the institution decision entered November 1, 2017 (Paper No. 7). On this same day, Petitioner also filed an appeal; accordingly, this notice concerns a cross-appeal.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner states that the issues for appeal include, but are not limited to: the Patent Trial and Appeals Board (“Board”)’s determinations in the institution that Claims 1, 2, and 7-9 of U.S. Patent No 6,510,466 B1 (the “’466 patent”) were shown by a reasonable likelihood to be unpatentable; the Board’s subsequent determination that Claims 1, 2, and 7-9 are unpatentable; the Board’s consideration and analysis of the expert testimony, prior art, and other evidence in the record; and the Board’s factual findings, conclusions of law, or other determinations supporting or relating to the above issues.

Pursuant to 35 U.S.C. § 142 and 37 C.F.R. § 90.2(a), this Notice is being filed with the Director of the United States Patent and Trademark Office. Simultaneous with this submission, a copy of this Notice is being filed with the Patent Trial and Appeal Board. In addition, a copy of this Notice, along with the required docketing fees, is being filed with the Clerk’s office of the United States Court of Appeals for the Federal Circuit.
