**PETITIONER'S NOTICE OF APPEAL**

Pursuant to 37 C.F.R. § 90.2(a) and 35 U.S.C. §§ 141(c), 142, and 319, Bitdefender Inc. ("Petitioner") respectfully gives notice that it appeals to the United States Court of Appeals for the Federal Circuit from the Patent Trial and Appeal Board's Final Written Decision entered on October 25, 2018 (Paper 24), and from other related orders, decisions, rulings, and opinions underlying the Board's decisions.

For the limited purpose of providing the Director of the United States Patent and Trademark Office with the information specified in 37 C.F.R. § 90.2(a)(3)(ii), the issues on appeal include the Board's determination that Petitioner did not establish that claims 15-17, 22-24, 30, and 35-37 of the '466 patent are unpatentable under 35 U.S.C. § 103 in view of the grounds of unpatentability on which trial was instituted (Paper 14). The issues on appeal also include any finding or determination supporting or related to these issues, as well as all other issues decided adversely to Petitioner in any order, decision, ruling, or opinion.
