Patent Owner filed motions for *pro hac vice* admission of Andrew Danford (Paper 28), Robert J. Gunther, Jr. (Paper 24), Daralyn J. Durie (Paper 25), Lisa J. Pirozzolo (Paper 27), and Kevin S. FURTHER ORDERED that Mr. Danford, Mr. Gunther, Ms. Durie, Ms. Pirozzolo, and Mr. Prussia are authorized to represent Patent Owner only as back-up counsel in the instant proceedings;

FURTHER ORDERED that Patent Owner is to continue to have a registered practitioner represent it as lead counsel for the instant proceedings;

FURTHER ORDERED that Mr. Danford, Mr. Gunther, Ms. Durie, Ms. Pirozzolo, and Mr. Prussia shall comply with the Office Patent Trial Practice
