**PETITIONER'S REQUEST FOR
REFUND OF POST-INSTITUTION FEES**

Petitioner Intel Corporation (“Petitioner”) requests a refund of post-institution fees in the amount of \$14,000.

On May 9, 2017, Petitioner filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,805,948. As required by 37 C.F.R. § 42.15(a), Petitioner deposited \$23,000 with the U.S. Patent and Trademark Office (“USPTO”) at the time of filing the Petition to cover associated fees. Petitioner’s payment consisted of \$9,000 in fees associated with the request for *Inter Partes* Review, and a further \$14,000 in post-institution fees.

On November 22, 2017, the Board issued a Decision Denying Institution of *Inter Partes* Review (Paper No. 8). On January 25, 2018, the Board issued a Decision Denying Petitioner’s Request for Rehearing. *Inter Partes* Review was thus not instituted. Accordingly, Petitioner requests a refund of the post-institution fees paid to the USPTO in connection with this proceeding, totaling \$14,000, to be paid to deposit account No. 506499 (referencing Attorney Docket No. 53920.0128).
