COVER ART; Expression of globin genes. The flow of genetic information from the DNA sequence to the final protein product involves several discrete steps. First, the coding strand is copied into RNA by a process called transcription. Processing of the RNA species includes modifications of the 5' end, referred to as capping, addition of adenosines on the 3' end, and splicing to remove intron sequences. The final mRNA species is transported to the cytoplasm where it is translated into protein. The α- and β-like chains assemble spontaneously to form hemoglobin molecules. Mutations that cause thalassemia may interfere with any one of these major processes, namely transcription, processing, transport, or translation.
