7. Any additional issues the parties raise or propose to raise at or before the oral argument; and
8. Any additional issues on which the Board seeks information or clarification.

Petitioner requests the ability to use audio-visual equipment to display demonstratives and exhibits, including the use of a computer-connected projector, an ELMO projector, and a screen.
