Petitioners object to the following demonstrative exhibits served by PO:

- 1. **PODX2**, **21-25**, **27-31**, **35**, **38**, **39**, **43-44**, **46-50**, **and 80**, which excerpt portions of lab notebooks (Exs. 2001-2009) omitting or obscuring the full signature block, and are therefore misleading and prejudicial (FRE 403).
- 2. PODX2, 11, 12, 13, 16-52, 59, 80, and 108, which excerpt, quote, and/or cite exhibits that are subject to Petitioners' Motion to Exclude (Paper 67).
- 3. PODX3, 4, and 5, which contain new argument and briefing on previously uncited portions of exhibits.
- 4. **PODX54, 56, and 62**, which contain new argument and briefing on a new and misleading claim construction position.
- 5. PODX18, 20, 26, 32, 34, 37, 40, 42, 45, 51, and 59, which contain previously undisclosed diagrams, with new and misleading characterizations of evidence.
- 6. PODX11, 16-17, 19, 21, 49-50, 57, 71-72, 82, 96, 100-102, and 109, which misstate and/or mischaracterize the evidence.

Per the Board's Order, the parties met and conferred in good faith to resolve these objections, and were unable to resolve the issues. Paper 69 at 3-4.
