PDX48 (citing Paper 39 at 11-12; Ex. 1006; Ex. 1039 at 2-3; Ex. 1081) contains new argument and new reliance on specific pages of Ex.1039 not included in Paper 1 or 39;

PDX16-18, 21 (citing Paper 39 at 11-12; Ex. 1006 at 6683; Ex. 1159 ¶¶ 101-103; Ex. 2027 at 163:18-164:15; Ex. 1085); **PDX20** (citing Paper 39 at 11; Ex. 1006 at 6683; Ex. 2027 at 163:18-164:15; Ex. 1085) rely on arguments and evidence not cited in Ground 1 (or Grounds 2 and 3);

PDX33, 40 (Ex. 1004 at 630 (beginning "It was of interest...")); PDX34, 55 (Ex. 1005 at 1 (first callout beginning "mTOR TARGETING...")); PDX36 (Ex. 1006 at 6680 (third passage beginning "However, the poor...")); and PDX38 (Ex. 1006 at 6680) newly focus on different aspects or portions of the exhibits than were relied on in Paper 1 or 39.
