## I. INTRODUCTION

Watson Laboratories, Inc. (“Petitioner” or “Watson”) moves for an Order allowing Mr. Kurt A. Mathas to appear *pro hac vice* on behalf of Petitioner. IPR2017-01621, Paper 12; IPR2017-01622, Paper 11; *see also*, Ex. 1167 (Declaration of Mr. Mathas in Support of Motion for *Pro Hac Vice* Admission). United Therapeutics Corp. (“Patent Owner” or “UTC”) has not opposed the motion.

Petitioner’s motion is *granted*. Petitioner shall confirm that its mandatory notices and official electronic file records have been updated accordingly. Counsel recognized *pro hac vice* shall comply with 37 C.F.R. Parts 11 and 42 and the Office Patent Trial Practice Guide, 77 Fed. FURTHER ORDERED that Mr. Mathas shall be subject to the Office’s disciplinary jurisdiction under 37 C.F.R. § 11.19(a) and the Office’s Rules of Professional Conduct set forth in 37 C.F.R. §§ 11.101–11.901.
