**PATENT OWNER'S REQUEST FOR ORAL
ARGUMENT**

Patent Owner Uniloc 2017 LLC hereby requests oral argument pursuant to 37 C.F.R. §42.70, the Scheduling Order (Paper 9). Patent Owner requests that the Oral Argument be held at the Texas Regional Office in Dallas, Texas.

Patent Owner is filing concurrent requests for oral hearing in related cases: IPR2017-01797, IPR2017-01798, IPR2017-01799, IPR2017-01800, IPR2017-01801, and 2017-01802.
