Pursuant to 37 C.F.R. § 42.70 and the Board's Scheduling Order dated February 6, 2018 (Paper 9), Samsung Electronics America, Inc. ("Petitioner") requests Oral Argument on issues related to the patentability of claims 1–3 of U.S. Patent No. 8,243,723 ("the '723 patent"). Petitioner wishes to present argument on the following issues:

- Grounds at issue in this proceeding;
- Any issue addressed in Petitioner's papers, including but not limited to, the Petition and Petitioner's Reply to Patent Owner's Response;
- Motions to exclude filed in this proceeding (if any); and
- Rebuttal to Patent Owner's presentation on all issues, including the issues listed above and any issues raised in Patent Owner's Response or elsewhere in the record for this proceeding.

the Silicon Valley Regional Office. Petitioner requests permission to use audio/visual equipment to display demonstrative exhibits.
