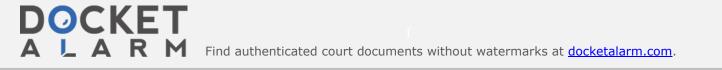

PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES



Ubisoft, Inc.. ("Petitioner") filed a petition for *Inter Partes* Review of 45 claims of U.S. Patent No. 6,324,578 on July 21, 2017 (Paper No. 3). At the time of filing, Petitioner submitted a fee of \$39,400.00 consisting of a \$9,000.00 request fee, a \$4,800 claim fee in excess of 20 claims, a \$14,000.00 *inter partes* review post-institution fee, and a \$11,600 post-institution claim fee in excess of 15 in accordance with 37 C.F.R. § 42.15(b).
