Pursuant to our authorization, Patent Owner filed a Motion to Withdraw Joshua J. Miller as back-up counsel in each of the above-identified proceedings. IPR2017-01841, Paper 47; IPR2017-01843, Paper 45. Patent Owner indicates that Petitioner does not oppose the Motions. *See* Mot. 2³.
