***Reasons for Allowance***

1. Claims 15 to 39 are allowed.
2. The following is an examiner's statement of reasons for allowance: A MISFET as claimed including a gate electrode protruding upward from a surface level of parts of a silicon nitride film located on the gate electrode's sides could not be anticipated nor, in combination, be rendered obvious over the prior art of record.
