PETITIONER REQUEST FOR REFUND OF POST-INSTITUTION FEES

Pursuant to 37 C.F.R. § 1.26, Petitioner respectfully requests a refund of the post-institution fees paid with its Petition for *Inter Partes* Review.

On September 14, 2017, Petitioner filed a Petition for *Inter Partes* Review of claims 29-39,42,43 of U.S. Patent No. 6,473,858. Petitioner submitted therewith the *inter partes* review request fee of \$9,000.00, pursuant to 37 C.F.R. § 42.15(a)(1), and the *inter partes* review post-institution fee of \$14,000.00, pursuant to 37 C.F.R. § 42.15(a)(2).
