PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES

Petitioner Google Inc., formerly Google LLC, (hereinafter, "Google"), respectfully requests a refund of all post-institution fees in this proceeding, in the amount of \$15,000.

On September 7, 2017, Petitioner filed a Petition for *Inter Partes* Review of U.S. Patent No. 8,581,991. In accordance with 37 C.F.R. § 42.15(a), Petitioner deposited a total amount of \$30,500 with the U.S. Patent and Trademark Office ("USPTO") at the time of filing the Petition for associated fees. Petitioner's deposit included payment of \$15,500 as a request fee and a post-institution fee of \$15,000. In total, Petitioner paid post-institution fees amounting to \$15,000.
