DOCKET A L A R M Find authenticated court documents without watermarks at <u>docketalarm.com</u>. On May 3, 2018, the Board issued a Scheduling Order. *See* Paper 16. The Scheduling Order states that "[t]he parties may stipulate to different dates for DUE DATES 1 through 5 (earlier or later, but no later than DUE DATE 6)." *Id.* at 6. The Scheduling Order further states that "[a] notice of stipulation, specifically identifying the changed due dates, must be promptly filed." *Id.*

To allow for the exchange of voluntary discovery, Patent Owner Universal Secure Registry ("Patent Owner") and Petitioner Unified Patents (Petitioner), notify the Board that they have conferred and jointly agreed to modify certain deadlines under DUE DATE 1 and DUE DATE 2. DUE DATE 1 sets the date by which the Patent Owner must file "any response to the petition" (Patent Owner Response) and "any motion to amend" (Motion to Amend). Paper 16 at 7.¹ DUE DATE 2 sets the date by which the Petitioner must file "any reply to the patent owner's response" (Petitioner's Reply To Patent Owner Response) and any "opposition to a motion to amend" (Petitioner's Opposition To Motion To Amend). *Id.* Patent Owner and Petitioner stipulate to modify the deadlines as follows:
