PETITIONER'S REQUEST FOR REFUND

Petitioners ZTE (USA) Inc., Samsung Electronics Co., Ltd. and Samsung Electronics America, Inc. (“Petitioners”) request a refund in the amount of \$15,200 to be paid to deposit account number 50-0417.

On October 26, 2017, Petitioner filed a Petition for *inter partes* review of claims 1-18 of U.S. Patent No. 8,624,550 with the Patent Trial and Appeal Board that was assigned case number IPR2018-00110.
