**PETITIONER'S REQUEST FOR REFUND OF POST-INSTITUTION FEES**

Pursuant to the Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 Fed. Reg. 4212, 4232–4234 (Jan. 18, 2013), Petitioner, Initiative for Medicines, Access & Knowledge (I-MAK), Inc., requests a refund in the amount of \$14,000 to be credited to Deposit Account Number 601986.

On November 9, 2017, Petitioner filed its Petition for *Inter Partes* Review in this matter.
