PLAINTIFF’S IDENTIFIED TERMS AND PROPOSED CONSTRUCTIONS FOR U.S. PAT. NO. 5,822,523 (THE “523 PATENT”)

TERM	PROPOSED CONSTRUCTION
aggregated message	one or more messages containing destination data and data items from an aggregated payload
aggregated message/aggregated payload/server message	one or more messages/payloads
aggregating, by said server in a time interval determined in accordance with a predefined criterion, said payload portions of said messages to create an aggregated payload	The group messaging server forms an aggregated payload by aggregating at least one data item from the payloads of all the claimed messages it receives from the claimed plurality of host computers within a certain time period. The data items may be aggregated in any order and the time period is certain in that it must arise from criteria specified prior to the beginning of the time interval
aggregating/aggregated	<ul style="list-style-type: none"> • to collect two or more data items together as a unit, however, where each data item retains its identity and may be extracted from the unit • it is not necessary for the GMS to aggregate the entire payload portion of each message it receives from the host computers
create message	A message creating a message group
