Issues

- Petitioner has not sufficiently demonstrated a POSITA would have been motivated to combine Aldred (Ex. 1009) and RFC 1692 (Ex. 1010) – because such a combination would render Aldred unsatisfactory for its intended purpose
- 2. Claim Construction of "Aggregated Payload" and "Aggregated Message" Claim 1 (523 Patent); Claims 1, 3, 7, 12, and 18 (686 Patent)

- "Aggregated Message" ("Server Message" in Claim 18 of 686 Patent)
 - "One or more messages containing a single transport layer message header, destination data, and data items from an aggregated payload." (PO Resp., Paper 22, at 4)
- "Aggregated Payload" ("aggregating said payload portions" in Claim 3 of 686 Patent) ("aggregating said payload portion with the payload portion of a second host message" in Claim 18 of 686 Patent)
 - "A collection of two or more data items that does not include transport layer headers." (PO Resp., Paper 22, at 13)
