**PETITIONER'S REQUEST FOR REFUND OF
POST-INSTITUTION FEES**

Petitioner respectfully requests a refund of post-institution fees in the amount of \$14,000 to be paid to Deposit Account No. 03-3975.

On November 22, 2017, Petitioner filed a Petition for *Inter Partes* Review with the U.S. Patent and Trademark Office, Patent Trial and Appeal Board (“USPTO”) for the review of U.S. Patent No. 6,748,317. As required by 37 C.F.R. § 42.15(b), Petitioner deposited \$23,000 with the USPTO at the time of filing the Petition to cover associated fees.
