Remarks

Claims 1, 2, 3, 4, 7, 8, 9, 10, and 11 were all rejected under 35 U.S.C. §102 or §103. Applicants believe these claims are allowable over the cited art, but have canceled these claims to expedite prosecution of the application. The remaining claims were rejected under 35 U.S.C. §112, for the specific reasons cited on page 2 of the action.

Applicants have amended either the specific claims listed in the §112 rejection or the independent claims from which the rejected claims depend. It is believed that all of the §112 issues were addressed, but if the examiner disagrees, the undersigned counsel for Applicants is available for a telephone interview to expedite prosecution of this application.

Claims 5, 6, 9, and 13 all depended directly or indirectly from independent claim 1, now canceled. In claim 1 as originally filed, the last line included the phrase "calculate a distance measured by the step counter" to describe the function of the receiver after receiving a signal from the transmitter. In fact, the step counter does not "measure" anything. Step counters only count steps. In the invention as claimed herein, the receiver does the calculating based on the signal received from the step counter. Thus, in claims 5, 6, 9, and 13, the language of base claim 1 has been amended to make clear that the receiver calculates a distance traveled based, at least in part, on the signal received from the step counter.

Similarly, claim 12 depended from intervening base claim 9, which included the phrase "a heart rate calculated by the heart rate monitor." The heart rate monitor does not "calculate" a heart rate. Rather, the heart rate monitor recited in claim 9 simply "monitors" or counts heart beats. The receiver then calculates and displays the heart rate. Thus, the claim 9 language added to claim 12 has been amended to clarify this point. Claim 25 includes a similar amendment.

In addition, claims 5 and 21 were amended to make the transmission range from zero to thirty-six inches. This reflects the broadest range supported by the specification at page 4, lines 23-29. So long as the signal is transmitted no more than the thirty to thirty-six inch range, it avoids interference with other Rf or digital devices. Given this, the two portions of the device can be mounted on different body parts without interference from external signals. Thus, zero inches is the smallest distance and thirty-six inches is the largest distance of transmission for this preferred embodiment as recited in claims 5 and 21.

Next, claim 37 was amended to accommodate the examiner's proposed changes to this claim. In addition, the "first run stride length" was given the dual name of "base stride length", and "first stride rate" was given the dual name "base stride rate". These terms are necessary to provide the necessary antecedent basis for the formula recited at the end of the claim.

The claims that were allowable if rewritten to overcome the §112 rejection and put into independent claim format have been amended to include all of the limitations of their respective base claims. Thus, all remaining claims are in condition for allowance. No new matter is believed to be added by this amendment.

Further, submitted herewith is a Supplemental Information Disclosure Statement citing a web page and instructions for a pedometer that is now commercially available. Applicants have no information indicating that this is prior art to the present application, but in the interest of full disclosure bring it to the examiner's attention. It is noteworthy that the instructions describe the pedometer as able to distinguish a walking stride length from a running stride length, and to calculate a "steps per minute". (Page 4, "Speed Function".) Significantly, however, this pedometer can only measure distance based on a uniform stride length. These instructions specifically state, "It is important to walk or run or hike consistently. If you vary your walking pace, your stride length will vary and your distance traveled will be [different]." (Page 3, "Your Stride Length".) Further, the user's stride length must be measured and then input into this pedometer's "memory". It does not measure stride length automatically. (Page 3, "How to

Measure Your Stride".) Thus, even if this pedometer were prior art, it has no bearing on the allowability of the claims, particularly those relating to variable stride lengths.

Conclusion

For the foregoing reasons, Applicants submit that this case is in condition for allowance and respectfully request that the application be passed to issue.

Wambach, Applicant submits the following amendments and remarks.

In the Claims

Please cancel claims 5, 6, and 14

Please amend claims 15 and 17 as follows:

2/13. (Twice Amended.) A pedometer comprising:

a step counter mountable on a user first body portion;

a transmitter in communication with the step counter to generate a signal

corresponding to each step and transmit the signal; and

a receiver mountable on a user second body portion to receive the signal transmitted

from the transmitter and use the signal to calculate a distance traveled,

wherein the pedometer includes a data processor programmed to calculate the

distance traveled by multiplying the number of strides taken by a stride length that

varies according to a rate at which strides are taken by:

timing a user first run of a predetermined distance;

counting the total number of strides in the user first run:

dividing the first run distance by the stride count to obtain a base stride length;

dividing the stride count by the first run time to obtain a base stride rate:

counting strides in a period of time during a user second run to obtain an actual

stride rate;

calculating the actual stride length using the formula:

Actual Stride Length = Base Stride Length + Base Stride Length *(((Actual Stride

Rate - Base Stride Rate)N)/Base Stride Rate);

where N is in the range of between 1 and 3.



M. (Twice Amended.) A pedometer comprising:

a step counter;

a transmitter in communication with the step counter to generate a step count signal corresponding to each step and transmit the step count signal; and a receiver mountable on a user body portion to receive the step count signal transmitted from the transmitter [and calculate a distance from a number of strides measured by the step counter]; and

Do

a data processor programmed to [calculate a distance traveled by multiplying the number of strides taken by a stride length that varies according to a rate at which strides are taken] use the step count signal to: calculate a stride rate and a stride length from a plurality of walks or runs each over a known distance to generate a range of corresponding stride rates and stride lengths.

and in subsequent walks or runs, calculate an actual stride rate from the number of strides counted by the step counter over a unit of time, compare the actual stride rate with the range of corresponding generated stride rates and stride lengths, and therefrom, calculate an actual stride length to be used in calculating an actual distance traveled.

Remarks

The undersigned counsel for Applicant wishes to thank Examiner Wambach for the courteous and productive telephone interviews of June 12 and 15, 2000. In the June 12, 2000 interview, Examiner Wambach indicated that Kato, U.S. Patent No. 5,033,013 and Hutchings, U.S. Patent Nos. 5,724,265 and 5,899,963 disclosed a correspondence between stride rate and stride length. Consequently, any claims based on this broad concept were not allowable, but

clause, reciting a specific algorithm for deriving a range of stride lengths or a pedometer in combination with a heart rate monitor are allowable.

On June 15, 2000, the undersigned counsel for Applicant telephone Examiner Wambach indicating that a distinction between the art of record and the present pedometer invention is the use of data input from runs or walks over known distances to establish a range of stride rate versus stride length data that can be used in subsequent runs or walks to derive actual stride lengths from actual stride rates. Therefore, claim 17 has been amended to include language addressing this novel and non-obvious concept. This is not new matter, rather it simply describes the broad concept discussed throughout the application of using trial runs/walks to obtain a range of data to be used for use in subsequent runs or walks.

Claims 5, 6, and 14 have been canceled.

Claim 13 was combined with what is believed to be its allowable dependent claim 14.

Thus, amended claim 13, and its respective dependent claims are allowable.

Conclusion

Applicant submits that the present application with its remaining claims is in allowable form and in condition for allowance. Applicant respectfully requests that this application be passed to issue.







Your new pedometer has been designed for your easy use and the accurate measurement of the distance you travel (travel distance records up to 7 days in memory), the steps you take, the calories "burned" while you walk or run, how long you exercise, what speed you walk or run, conversion of distance measurement from mile (MIL) to kilometer (KM) or kilometer to mile, and auto power on/off. Also included is a convenient Time-of-Day clock with 12 hour or 24 hour format to tell you what time it is. The unit will also measure your distance in miles/kilometers and fractions of miles/kilometers.

Your pedometer has a very unique scanning feature. After you turn on the pedometer the display will be in STEP mode. Press "C" button once or repeatedly to show TIMER, CAL, KMH or MIL/H, STEP/M and Time of Day modes. When you return back to the STEP mode, it will be "blinking". You are now in the Auto-Scan mode. Now the display will automatically show the blinking words "STEP, TIMER, CAL, KM/H or MIL/H, STEP/M and Clock". The pedameter will now rotate through each one of these displays for 3 seconds sequentially as long as the auto-scan function is activated... or until you press the "C" button once more for new data setting or viawina.

HOW TO OPERATE YOUR NEW PEDOMETER

You will need to give your pedometer some information for it to operate properly. In the sections below you will see how to enter your personal STRIDE LENGTH (for welking, hiking), your WEIGHT (for calories), and TIME OF DAY. Once this information has been entered into the unit, yau're ready to go!

YOUR STRIDE LENGTH (Your stride length and how to measure it)

This pedometer automatically records your exercise distance based upon your walking or running or hiking movements. The maximum distance reading is \$99.99 miles/kilometers. The numbers to the right of the decimal point are fractions of a mile (just like your car's odometer) right down to 1/100 of a mile or kilometer. It is important to walk or run or hike consistently. If you vary your walking pace, your stride length will vary and your distance traveled will be diffe-rent.

HOW TO MEASURE YOUR STRIDE

In order to measure your exercise distance accurately, you must anter your stride langth into the Pedometer's "memory" so it knows how much distance you cover with each step you take. (Stride length is the length of each one of your steps, measured either from heel to heel or tae to toe). It's easy to find your stride length?

 Walk 10 steps. 2. Measure the distance. 3. Divide by 10 the distance covered to arrive at your stride length. 4. Example: Distance covered in 10 steps = 30 feet. Steps taken to cover the distance (10 steps), 30 feet divided by 10 steps = 3 feet, stride length = 3 feet,

FOR JOGGERS OR HIKERS

Follow the directions above, except jog or hike for 10 steps.

HOW TO ENTER YOUR "WALK" STRIDE LENGTH INTO THE PEDOMETER

1. Press the MODE button "C" on the display panel to STEP mode, and hold for 2 seconds to get to the WALK stride length setting mode. 2. Press button "A" + "B" for setting your WALK stride length information, every press of button "A" will increase 1 inch or 1 cm. Every press of button "B" will decrease 1 inch or 1 cm in the reverse order. 3. After you set your WALK stride langth

information, the numbers of the stride langth on the display will blink for confirmation and go > STEP mode automatically alter 5 seconds.

HOW TO ENTER YOUR "RUN" STRIDE LENGTH INTO THE PEDWAETER

1. Press the MODE button "C"on the display panel to STEP mode, and hold for 2 seconds to WALK stride length selling mode, press MODE button "C" once again to get RUN stride length setting mode. 2. Press button "A" + "B" for setting your RUN stride length information (the

HOW TO SET CALORIE COUNTER

Press the MODE button "C" and the display panel until you see CALORIE mode.
 Press MODE button "C" and hold for 2 seconds to get WEIGHT setting mode.
 Press button "A"+"B" to set your weight information. Every press on button "A"

increases the weight by 10 LB (pounds) or 4.5 KG (kilograms). Every press of button "B" decreases the weight by 10 LB (pounds) or 4.5 KG (kilograms). 4. Once you set the proper weight, the display will blink for 5 seconds end then the display will skip back to CALORIE mode.

HOW TO SET TIME OF DAY

1. Press the MODE button "C" on the display panel repeatedly to reach CLOCK mode.

2. Press button "C" once and hold for 2 seconds to get 12 or 24 hour time setting mode. Press either button "A" or "B" ouce to set 12 hour time format or 24 hour time format. 3. Press MODE button "C" once to get into CLOCK setting. Press button "A" for hour setting and "B" button for minute setting. After completing the setting, display will automatically go back to CLOCK mode after 5 seconds.

TO START YOUR EXERCISE

I. Press "C" until the upper display will show STEP mode. Z. The display will show 00000 in the STEP mode in the upper display window lift numbers appear in either display, RESET the display by pressing "A" for 2 seconds), and 0.00 MiL or KM for distance on lower display window. 3. TO RESET YOUR PEDOMETER

Press the RESET button "A" and hold for 2 seconds. The upper display and lower display will be reset to zero except the CLOCK mode and the previous 7 days distance travel records. TO RESET THE 7 DAY MEMORY, press and hold "A" for 5 seconds. All the digits will show. Release "A". The memory will clear. However, this will also change MIL to KM, or KM to MIL. Simply press and hold "A" for 5 seconds again to change back to your preferred (KM or MIL) distance measurement.

MILE / KILOMETER CONVERSION

To change from MILE to KILOMETER, press and hold RESET button "A" for 5 seconds. This will change STRIDE setting measurament from feet to cm (centimeters) as well.

HOW TO USE THE TIMER COUNTER

This pedometer accurately measures the time you spend exercising. When you stop, the timer stops. When you exercise, the timer runs. Press MODE button "C"on the display panel until you get to the TIMER made for viewing the record of your exercise time.

DISTANCE COUNTER FUNCTION

This feature allows you to count the distance you traval during an exercise period, or all day if

you wish. Your target should be to walk or jog 4 miles each day. Try it.

1. Press the MODE button "C" to get to STEP mode. 2. Press RESET button "A" and hold for 2 seconds and begin walking, running or hiking. The display will show 00000 and will begin to record your steps and distance.

DISTANCE WITH 7 DAY MEMORY & ODOMETER FUNCTION

This feature allows you to view the record of any day in miles or kilometers for 7 days. Starting from the 8th day, new data will automatically replace the memory of the 1st day recorded, and the 9th day will replace the 2nd day recorded... and so forth. Press and release button "A" to view each consecutive day's memory, and press button "B" to view each previous day's memory and total distance traveled "ODO" (like your car's adometer). Please note: You can complete your viewing of the 7 days activities and total distance before you return to the main pedameter functions OR press "C" once to return to the main pedameter functions.

Your pedameter clips easily to your trausers or shorts. For best results keep the unit in line with the "crease line" of your trousers. SENSITIVITY ADJUSTMENT

Everyone's welking style is different. This pedameter has an automatic sensitivity adjuster that compensates for the different welking, running or jogging styles, BATTERY REPLACEMENT

1. The battery hetch is on the side of your padometer. Slide open the battery door with your finger to access the battery Z. Replace battery with LR-44 type when display dims. 3. Reset the pedometer and reenter the WEIGHT/STRIDE length and CLOCK information. OTHER INFORMATION
