

Petitioner requests one hour in which to present its arguments. Under 37 C.F.R. § 42.70, and without intending to waive any issue not specifically identified, Petitioner specifies the following issues to be argued:

- 1. Whether claims 1-29 are unpatentable over the asserted art;
- 2. Whether claims 1-29 are obvious over Burnside (US 6,605,300 and RE41,148) alone or combined with prior art related to Adderall XR;
- Whether certain elements of claims 1-29 are inherent in the prior art, including but not limited to, the pharmacokinetic elements and the no food effect element;
- Patent Owner's defenses, including but not limited to, whether there was reasonable expectation of success, teaching away and secondary considerations;
- 5. Any issues specified by Patent Owner in its Request for Oral Argument;
- 6. Any other issues the Board deems necessary for issuing a final written decision (e.g., any motion to exclude evidence, any motion to strike briefs, and any motion to seal evidence).

Petitioner also requests that the Board provide audio-visual equipment to display demonstrative exhibits, including a projector and screen for displaying

documents from a computer.



Further, Petitioner requests that the hearing be held at the USPTO's Alexandria, Virginia office.
