(57) **ABSTRACT**

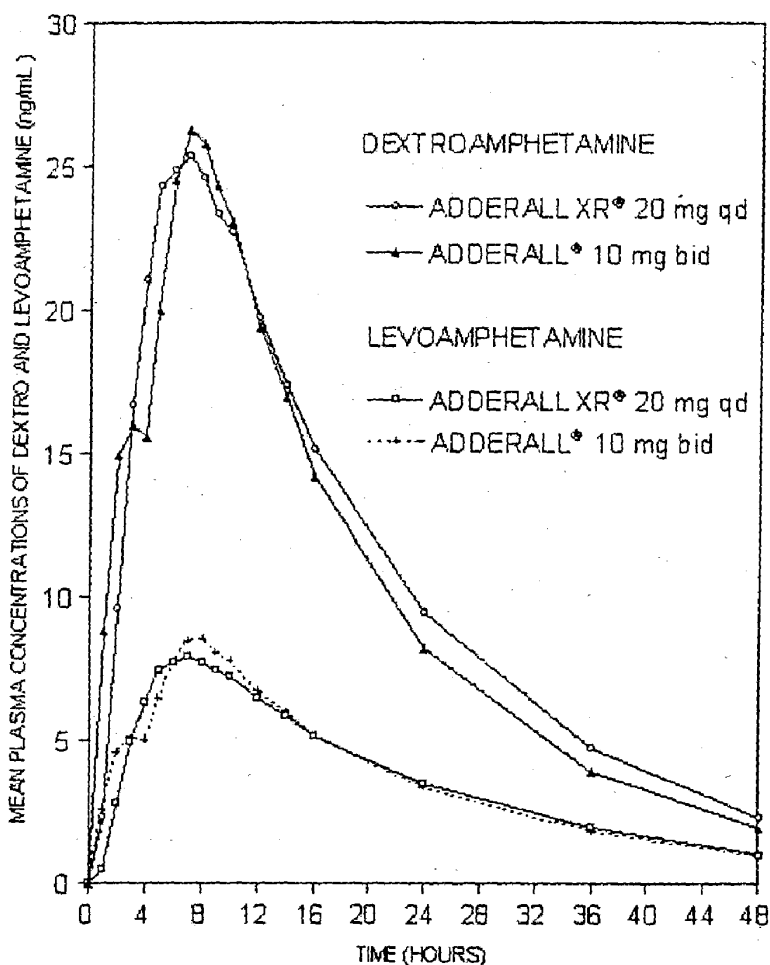

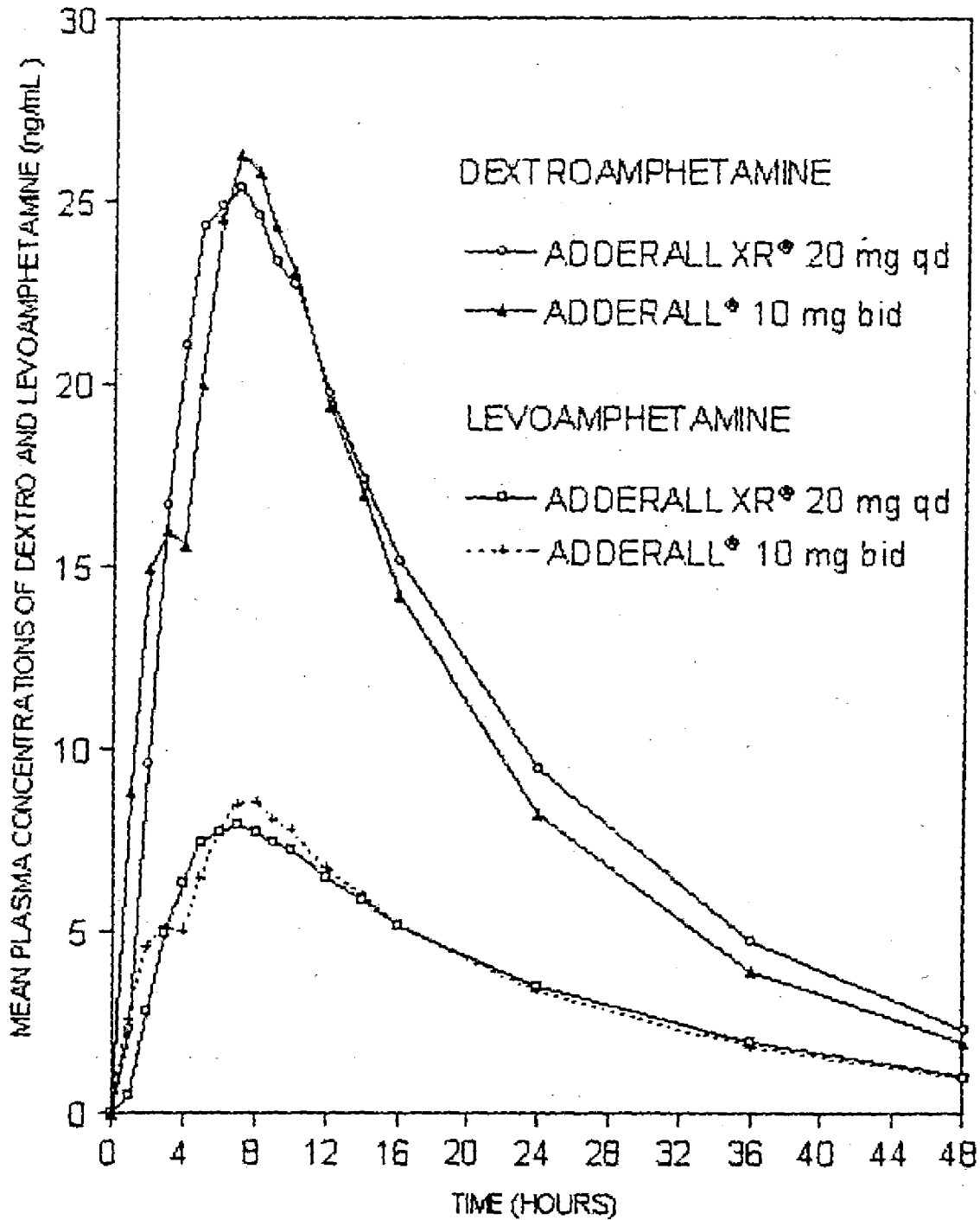
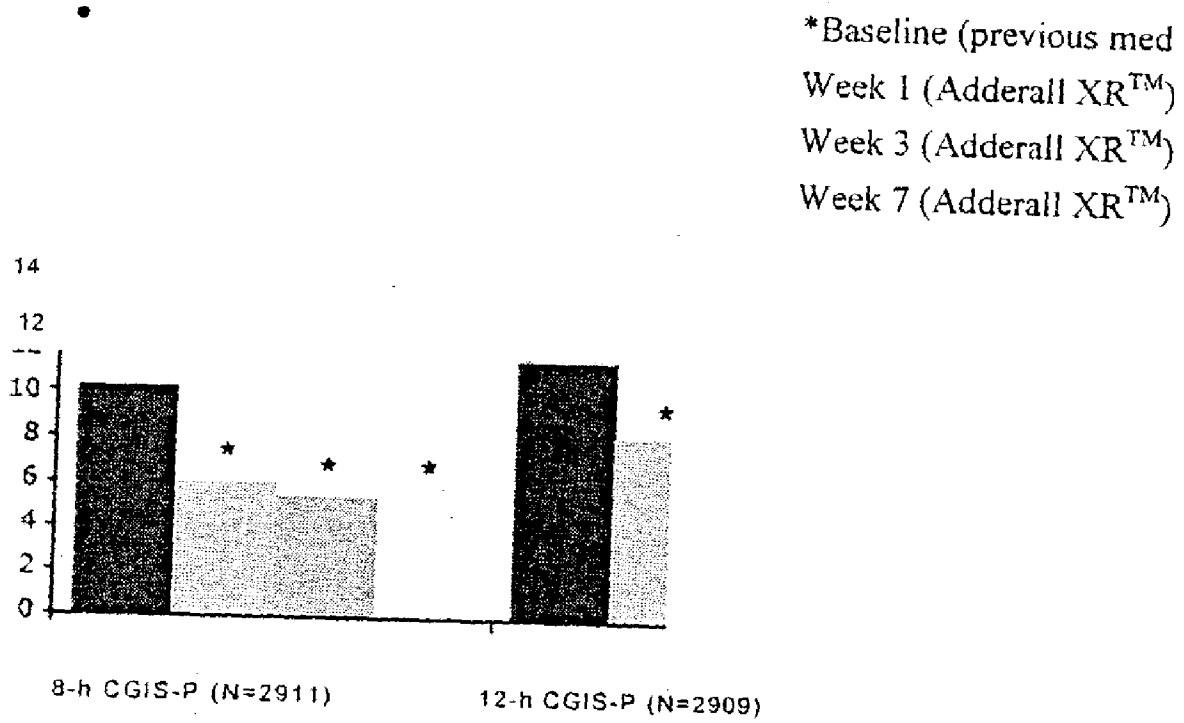


Figure 2. Mean CGIS-P total scores for ITT population.

Figure 3. CGI Improvement scores at week 7.

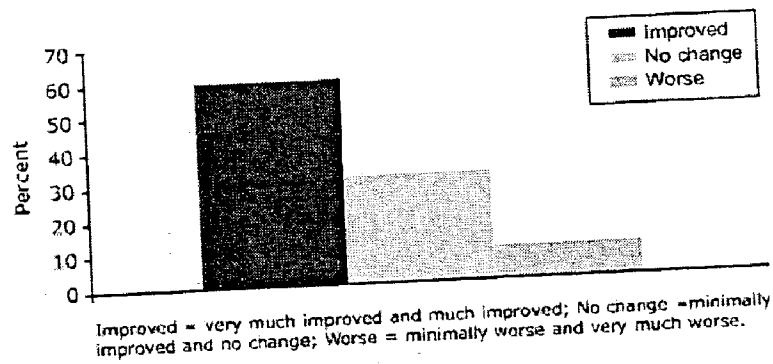
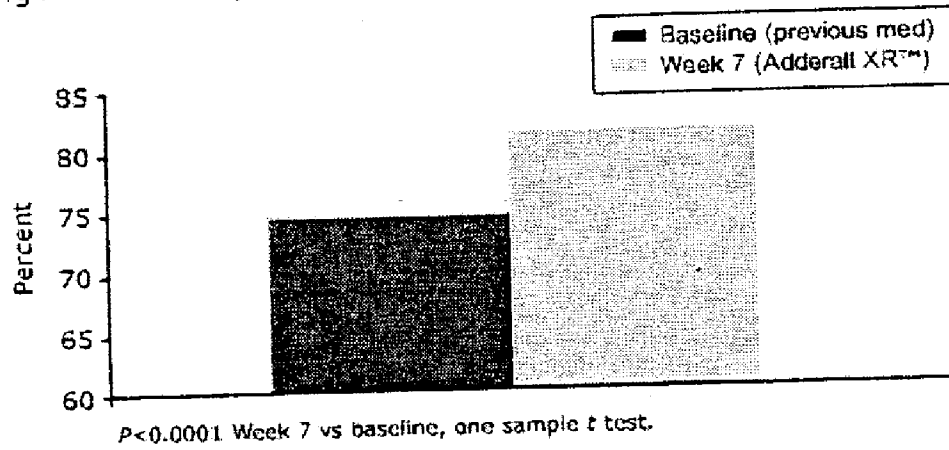


Figure 4. PedsQL total score.
