Pursuant to 35 U.S.C. §§ 141 and 142 and 37 C.F.R. §§ 90.2 and 90.3, Patent Owner Uniloc 2017 LLC. (“Patent Owner”) hereby provides notice that it appeals to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered June 17, 2019 (Paper 20); the Decision Denying Patent Owner’s Request for Rehearing entered August 16, 2019 (Paper 22); and from all underlying findings, orders, decisions, rulings, and opinions, including, without limitation the institution decision entered June 17, 2018 (Paper 7).

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Patent Owner states that the issues for appeal include, but are not limited to: the Patent Trial and Appeals Board (“Board”)’s determinations in the institution that Claims 1–3, 5-7, and 10-18 of U.S. Patent No 8,712,723 B1 (the “’723 patent”) were shown by a reasonable likelihood to be unpatentable; the Board’s subsequent determination that Claims 1–3, 5-7, and 10-18 are unpatentable; the Decision Denying Patent Owner’s Request for Rehearing; the Board’s consideration and analysis of the expert testimony, prior art, and other evidence in the record; and the Board’s factual findings, conclusions of law, or other determinations supporting or relating to the above issues.

Pursuant to 35 U.S.C. § 142 and 37 C.F.R. § 90.2(a), this Notice is being filed with the Director of the United States Patent and Trademark Office. Simultaneous with this submission, a copy of this Notice is being filed with the Patent Trial and Appeal Board.
