- 4. Patent Owner's and Petitioner's Motion to Exclude Evidence, if any;
- 5. Rebuttal of any arguments made by Petitioner;
- 6. Any additional issues on which the Board seeks clarification; and
- Response to any issues Petitioner raises in its Request for Oral Argument.
