**PATENT OWNER'S REQUEST FOR ORAL ARGUMENT**

**UNDER 37 CFR §42.8**

Patent Owner Uniloc 2017 LLC hereby requests oral argument on April 2, 2019 in accordance with 37 C.F.R. §42.70 and pursuant to the Scheduling Order (Paper 8). Given that Lead Counsel for both Patent Owner and Petitioner are located in the Dallas area Patent Owner respectfully requests that the Board conduct the hearing at the Texas Regional Office in Dallas, Texas. Patent Owner also requests that the oral hearing for this case be combined with that of IPR2018-01028. Each case is related to the '902 patent.

Patent Owner proposes no more than thirty (30) minutes per side. Patent Owner also requests permission to use audiovisual display equipment to present

demonstratives, including a projector and screen for computer-generated slides, and a document camera/projector. Patent Owner expects to have three or four people at the hearing.

5. Any issues specified in Patent Owner's Sur-Reply.
6. Any issues otherwise raised by the Board.
