On this page, I clicked on "Summary Review," which returned a pdf of a document, a true and correct copy of which is marked as Ex. 1013.

Exhibit 1020 is a true and correct copy of the prosecution history of U.S Patent No. 9,561,197 which I downloaded on December 11, 2017 from the U.S. Patent and Trademark Office's Patent Application Information Retrieval website, at <https://portal.uspto.gov/pair/PublicPair>.
