#### **DETAILED ACTION**

### Response to Arguments

1. Applicant's arguments, see pages 8-14 and Affidavit filed by the invetor, filed 10 May 2013, with respect to all pending claims have been fully considered and are persuasive. The previous rejection of all claims under the prior art has been withdrawn.

#### Allowable Subject Matter

- 2. Claims 1-25 and 27 are allowed over the Prior Art of record.
- 3. The following is an examiner's statement of reasons for allowance: All of the Prior art found typically only disclosed testing arrangements for simulated vascular structures, not heart valves or valved prostethics, having all of the elements and connectivity recited in instant independent claim 1, not the disclosed chamber to perform the testing of the posthetic device, as recited in instant independent claim 17 and the pressurization system recited in instant independent claim 25, wherein accelerated testing is capable of being perform3ed, and elastomeric rolling bellows are employed.
