On January 22, 2018, SMR Automotive Systems USA, Inc. (“Petitioner”) filed a Petition for *Inter Partes* Review (IPR2018-00520) seeking review of *all* claims (1-20) of U.S. Patent No. 8,267,534.

Due to a clerical error, Petitioner paid fees for 26 claims, not 20 claims, totaling \$38,900. The total for 20 claims is \$33,500. As a result, Petitioner overpaid by \$5,400.
