- III. Whether claim 117 is unpatentable under 35 U.S.C. § 103(a) over Stewart, Rush, and Church;
- IV. Whether claims 20 and 138 are unpatentable under 35 U.S.C. § 103(a) over Richardson and Stewart; and
- V. The proper construction of the term "reflecting."
