Petitioner submitted a motion in each of the above-identified proceedings for admission *pro hac vice* of Megan J. Redmond (collectively, "Motions"). Paper 8.<sup>2</sup> The Motions are supported by Declarations of Ms. Redmond. Ex. 1020. Powers of Attorney were filed for Ms. Redmond. Paper 2, 2. FURTHER ORDERED that Ms. Redmond shall comply with the Office Patent Trial Practice Guide, as updated by the August 2018 Update, 83 Federal Register 39,989 (Aug. 13, 2018), and the Board's Rules of Practice for Trials as set forth in Part 42 of Title 37, Code of Federal Regulations; and
