("Silver Star"), provides notice of its appeal to the United States Court of Appeals for the Federal Circuit of the Decision Denying Institution of *Inter Partes* Review entered on October 1, 2018, in case IPR2018-00897 (Paper No. 9), and from all underlying findings, orders, decisions, rulings, and opinions.
