PETITIONER'S REQUEST FOR ORAL ARGUMENT



Pursuant to 37 C.F.R. § 42.70(a) and the Scheduling Order (Paper 10),

Petitioner submits this Request for Oral Argument on all of the instituted grounds of unpatentability of U.S. Patent No. 8,998,058. A request for Oral Argument in related IPR proceedings (IPR2018-00933 and IPR2018-00935) are being filed on this same day. - 3. Whether substitute claims 23 and 28 are obvious over Viola in view of Heinrich and, if necessary, further in view of Young;
- 4. Whether claims 1-10 are obvious over Hooven in view of Heinrich;
- 5. Rebuttal to Patent Owner's presentation on all matters; and
- 6. Any additional issues on which the Board seeks clarification.

The Board has already scheduled Oral Hearing for September 5, 2019. *See* PTAB's Scheduling Order of December 7, 2018 (Paper 10).
