Pursuant to 37 C.F.R. § 42.70(a) and the Board's Order of May 14, 2019 (Paper 19), Petitioner respectfully requests that the Board hear oral argument on all instituted grounds of unpatentability in this proceeding, with 45 minutes allocated to each party.

Pursuant to 37 C.F.R. § 42.70(a), Petitioner specifies the following issues to be argued:

1. Claims 1, 3-5, and 10-12 are anticipated by Comer (Ground 1);
2. Claims 1, 3-5, 11, and 12 are anticipated by Nuwayser (Ground 2);
3. Claims 1-13 are obvious over Comer in view of Nuwayser, Rubio, and Wright (Ground 3);
4. Claims 1-13 are obvious over Nuwayser in view of Comer, Rubio, and Wright (Ground 4);
5. Claims 1-13 are obvious over Nuwayser in view of Kranzler, Rubio, and Wright (Ground 5);
6. Claims 1-13 are obvious over Alkermes's 10-K in view of the Vivitrex Specimen, Rubio, and Wright (Ground 6); and
7. Any other motion or paper filed concurrently with or subsequent to this request.
