**PETITIONER'S REQUEST FOR REFUND OF IPR FEES**

Petitioner Cipla Limited requests a refund in the amount of \$22,200 to be paid to Deposit Acct. No. 50-1710 (Customer ID No. 27160) pursuant to the U.S. Patent and Trademark Office's Final Rule Setting and Adjusting Patent Fees, 78 F.R. 4211, 4234-35 (Jan. 18, 2013).

On June 5, 2018, Petitioners filed a Petition for *inter partes* review against U.S. Patent No. 8,791,154, proceeding IPR2018-01020. In accordance with the fee schedule specified in 37 C.F.R. § 42.15(a), Petitioners deposited an electronic payment in the amount of \$ 39,800 with the PTO at the time of filing its Petition. Petitioners' payment consisted of \$ 17,600 in fees associated with Petitioners' *inter partes* review request, and a further \$ 22,200 in Post-Institution fees.
