Rob,

Regarding your first request, if Google cannot provide us with the scope of its proposed Petitioner Replies, then we cannot give you a definitive position. In your e-mail to the Board, you may state the following: "Regarding Google's first request, AGIS consents to Google's request to the extent that the proposed replies are substantively identical to Petitioner's Replies in IPR2018-01079, IPR2018-01081, IPR2018-01082, and IPR2018-01085. AGIS opposes any proposed reply that would differ in substance from the Petitioner's Replies as previously filed in IPR2018-01079, IPR2018-01081, IPR2018-01082, and IPR2018-01085."

Your second request amounts to an early motion to submit Supplemental Information which is—by rule—typically reserved for post-institution practice. The Board has not considered this extraordinary request in any of the Google-AGIS proceedings. The Board did not authorize (and Google did not request on the previous conference call) the filing of supplemental exhibits with Petitioner's Replies. You have not provided any reason or explanation of good cause for the Board to change the rules in this particular instance. Thus, we believe that a conference call is necessary, and we await your explanation before providing you with our position.

Dear Patent Trial and Appeals Board,

Petitioner Google requests permission to:

1. file a 3-page reply in IPR2018-01080, IPR2018-01086, and IPR2018-01088; and
2. file the joint claim construction from the district-court proceeding along with a one-page explanation in IPR2018-01083, IPR2018-01084, and IPR2018-01087.

Regarding (1), AGIS accused Google of a “lack of candor” for failing to identify claim constructions that LG, HTC, Huawei, Apple, and ZTE filed in district court after Google filed its IPR petitions. Google requests a reply to respond to this accusation. The Board granted a similar request in IPR2018-01079, IPR2018-01081, IPR2018-01082, and IPR2018-01085.

Regarding (2), AGIS has not yet filed its POPR. Google requests permission to file the joint claim construction from the district court along with a one-page explanation to describe the claim-construction positions taken in the district court.

Google reached out to AGIS about these requests on September 21. AGIS indicated that it [will/will not] oppose Google’s request.
