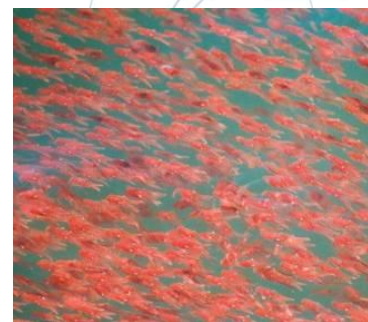
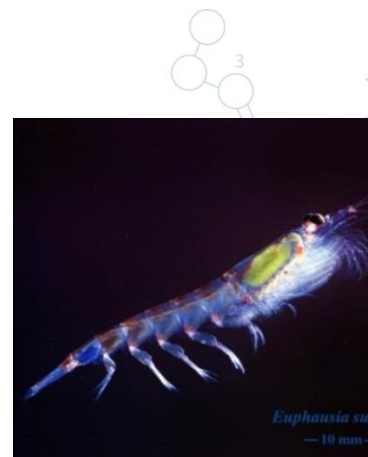

- Catch is regulated by CCAMLR



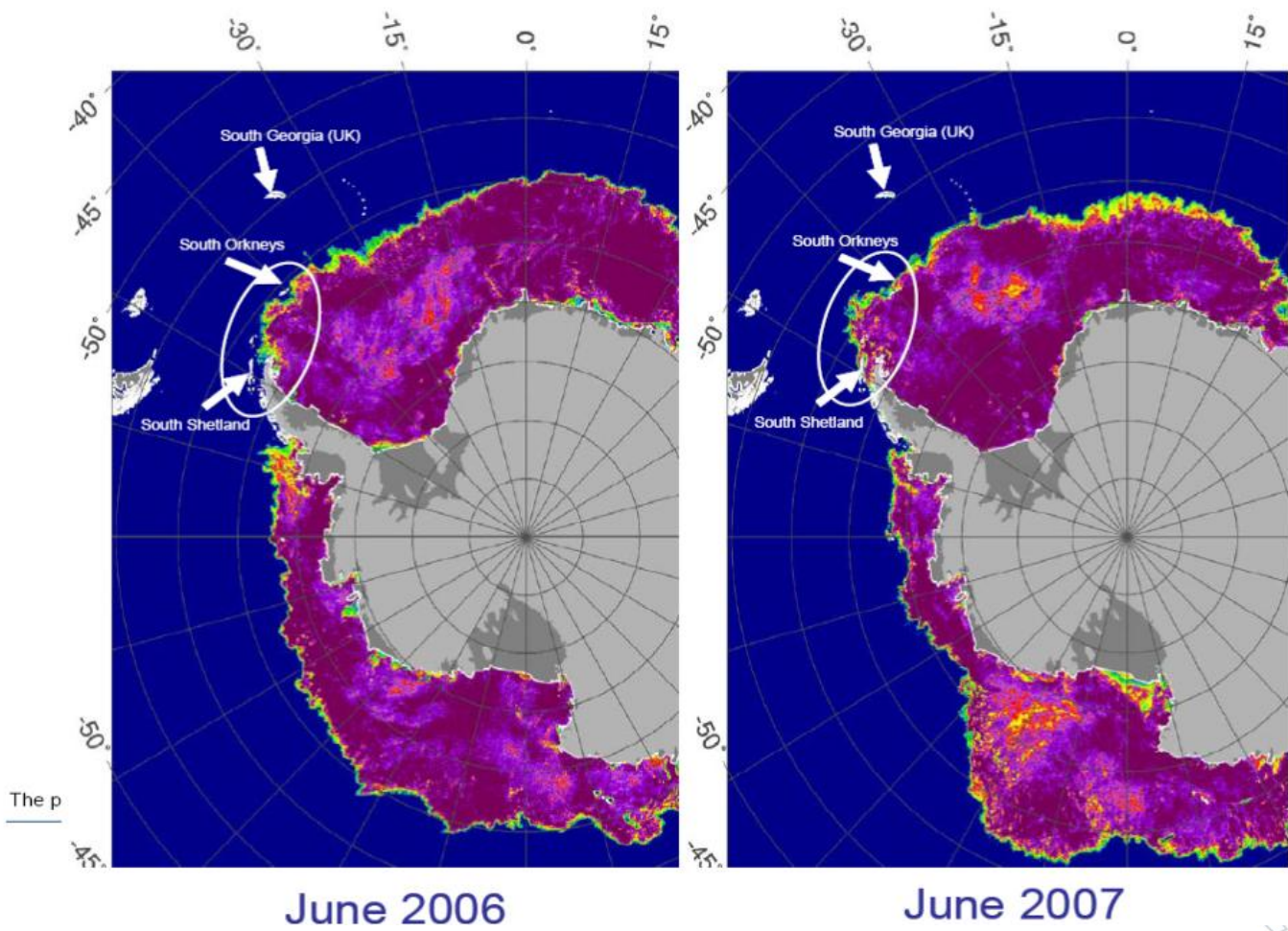
