Pursuant to 37 C.F.R. § 42.70 and the Board's February 4, 2019, Scheduling Order (Paper 23), Patent Owner respectfully requests oral argument on the issues raised in the Petition for Inter Partes Review of U.S. Patent 9,769,477, Patent Owner's Preliminary Response, Patent Owner's Response, Petitioner's Reply to Patent Owner's Response, and Patent Owner's Sur-Reply to the Petition. Per the Board's February 4, 2019 Order (Paper 23), oral argument is currently scheduled for October 15, 2019.
