Specifically, Qualcomm plans to present arguments on:

- 1. The correct construction of the claim term "a P-channel metal oxide semiconductor (PMOS) transistor [having]... a source that receives the boosted supply voltage or the first supply voltage";
- 2. Why claim 10 is not obvious under 35 U.S.C. § 103 over Chu, Choi 2010, and Hanington;
- 3. Why claims 10-11 are not obvious under 35 U.S.C. § 103 over Chu, Choi 2010, Hanington, and Myers;
- 4. Any additional issues on which the Board seeks clarification, or which the Board deems necessary for issuing a final written decision.
