PETITIONER'S REQUEST FOR ORAL ARGUMENT

Pursuant to 37 C.F.R. § 42.70(a) and the Board's Scheduling Order (Paper 8), Petitioner submits this Request for Oral Argument on all of the instituted grounds against the Challenged Claims of U.S. Patent No. 8,768,865. Petitioner requests 60 minutes for each side (120 minutes total) to present arguments for this proceeding.

Specifically, Petitioner requests (without waiving consideration of any issue not listed below) to address the following issues:

1. The anticipation of claims 1–4, 15–17, 21–23, 28-29 and 46-47 in view Wang;
2. The obviousness of claims 5-6, 8–11, 18–20, 24-25, 27, 30, 48-49 and 51–53 in view of Wang and Nadkarni;
3. The obviousness of claims 12-14 in view of Wang, Nadkarni and Greenhill;
4. Discussion of any motions to exclude;
5. Rebuttal to Patent Owner's presentation on all matters; and
6. Any additional issues on which the Board seeks clarification.

Petitioner also respectfully requests the ability to use audio visual equipment to display demonstrative exhibits, including the use of a projector and screen that connects to a laptop computer. Petitioner's counsel will use a laptop computer

with a VGA-type connector. In addition, Petitioner requests that an ELMO-type projector be made available for use.
