**REQUEST FOR REFUND OF POST-INSTITUTION FEE**

Petitioner Cisco Systems, Inc. hereby requests a refund of **\$17,400**, which includes the post-institution fee that was previously paid by Petitioner. Petitioner filed a Petition for Inter Partes Review of claims 1-6, 8-12, 14-17, 19, 21, 22, and 24 of U.S. Patent No. 8,934,535 on June 12, 2018, and paid the USPTO the \$15,000 inter partes review request fee, the \$15,000 post-institution fee, and the \$2,400, post-institution excess claims fee for nineteen claims in excess of fifteen as required by 37 C.F.R. § 42.15(a) (2017).

On October 16, 2018, the Board issued an Order Dismissing Petition. Because no institution decision was handed down and dismissal occurred during preliminary proceedings, Petitioner is entitled to a refund of \$17,400.00 for the post-institution fee and the post-institution excess claims fee. *See* 78 FED. REG. 4212, 4234 (Jan. 18, 2013) (“[I]f the review is not instituted at all, the portion of the fee covering the trial would be returned.”).

Petitioner therefore requests a refund of the \$17,400.00 post-institution fee.
