#### I. INTRODUCTION

In IPR2019-00789, Sawai USA, Inc. and Sawai Pharmaceutical Co., Ltd. (together, "Sawai") filed a Petition requesting an *inter partes* review of claims 1–20 of the '514 patent. IPR2019-00789, Paper 1. Sawai additionally filed a motion to join case IPR2018-01403 as a party. IPR2019-00789, Paper 2. We granted Sawai's Petition and motion for joinder and terminated IPR2019-00789. Paper 60.

Biogen MA Inc. ("Patent Owner" or "Biogen") filed a request for rehearing of the Board's decision of Sawai's Petition and motion for joinder. Paper 62.

Subsequently, Sawai and Biogen jointly requested that this case be terminated with respect to Sawai due to a settlement. Paper 94. We granted the joint request to terminate this proceeding with respect to Petitioner Sawai. Paper 96. Consequently, Sawai is no longer a party to this proceeding and Biogen's request for rehearing is moot. Accordingly, we dismiss Biogen's request for rehearing as moot.

#### II. ORDER

In consideration of the foregoing, it is hereby:

ORDERED that Patent Owner's request for rehearing is dismissed.
