Patient Assistance Programs for Korlym

- 3. Medically appropriate condition/diagnosis
- 4. Must reside and receive treatment in US
- 5. *Patients must have health insurance and their insurance must cover the qualifying medication for which they seek assistance. Call for most recent medications as the list is subject to change and the medication for which you are seeking assistance must treat the disease directly. Note: All new enrollment is now done electronically or over the phone. Contact program for details.
