It has come to Par's attention that in the process of finalizing the Petition and Declaration of Dr. Neal Sondheimer (EX1002) that was served on August 16, 2018 that some of the "μ" symbols in the documents were corrupted.

Par contacted the Board to inquire if the Board would prefer Par to file its Petition with the corrupted "μ" symbols corrected or to file the served version of the Petition with a motion to file a corrected Petition under 37 C.F.R. § 42.104(c).
