Pursuant to 35 U.S.C. §§ 141-144 and 319, and 37 C.F.R. § 90.2-90.3 notice is hereby given that Petitioners Apple Inc., HTC Corporation, and HTC America, Inc. ("Petitioners") appeal to the United States Court of Appeals for the Federal Circuit from the Final Written Decision entered February 28, 2020 (Paper 37) in IPR2018-01555, and all prior and interlocutory rulings related thereto or subsumed therein.

In accordance with 37 C.F.R. § 90.2(a)(3)(ii), Petitioners' issues on appeal include at least:

- (i) the Board erred in failing to find claims 1-7 of U.S. Patent No. 7,848,439 unpatentable; and
- (ii) any findings or determinations supporting or related to the aforementioned issues as well as all other issues decided adversely to Petitioners in any orders, decisions, ruling, phone conference decisions, and/or opinions.
