

Upon consultation with my superiors, I would like to inform that we will refrain from providing a letter in this detailed form.

When we received similar queries in relation to dissertations from Stuttgart in previous years, a brief e-mail or a brief confirmation with our letterhead was enough until now.

And in this case, it does not even concern a dissertation from Stuttgart; it concerns a work from Eindhoven.

If a brief confirmation of the facts should not be sufficient, then the process would have to firstly be agreed with the legal advisor of the university. We can confirm the following information to you:

We have received the dissertation of Willibrordus Johannes van Gils with the shelfmark Diss. 1988/2295 and incorporated it in the conventional card index of the University Library of Stuttgart in the year 1988. We can no longer determine the exact date, when we incorporated the work.

We have then referred to the dissertation on August 13, 1992 retrospectively in our online-catalog.

The dissertation from Willibrordus Johannes van Gils with the shelfmark Diss. 1988/2295 was registered in the conventional card index of the University Library Stuttgart in 1988. We are not able to determine the exact date of acquisition.

On August 13, 1992 the title retrospectively recorded in our online catalog.
